Overview

Jeff Siegel represents employers in virtually every labor and employment scenario. Jeff advises on and prepares restrictive covenant agreements, including agreements under the Massachusetts Noncompetition Agreement Act, and litigates to enforce or defeat non-competition, non-solicitation, and trade secret matters. He also counsels clients in day-to-day human resources matters, including employment policies and handbooks, wage and hour matters, bonus and commission plans, layoffs, and employee leave issues.

Jeff brings firsthand, employer-side knowledge that helps clients make important strategic and operational decisions. When representing clients in litigation and administrative charges, Jeff defends against claims of discrimination (e.g., Title VII, ADA, ADEA, Chapter 151B of the Massachusetts General Laws), improper payment of wages (e.g., FLSA, Massachusetts Wage Act), as well as state common law, breach of contract, wrongful termination, and defamation claims. Jeff also handles labor-related matters, including arbitration proceedings and charges filed before the National Labor Relations Board (NLRB). Jeff appears regularly in federal and state courts, and before government agencies including the EEOC, MCAD, Department of Labor, Attorney General's Office, as well as state anti-discrimination agencies across the country. Jeff is a member of the Boston Bar Association and the New Hampshire Bar Association.

With vast experience advocating for and defending employers, a sampling of his work with clients includes:

- Successfully obtaining summary judgment for client and senior manager in claim of discrimination in Massachusetts Superior Court.
- Representing a retailer in a race discrimination trial that resulted in defense verdict, and successfully

defended verdict at appeal in Third Circuit Court of Appeals.

- Representing a client in enforcing restrictive covenant and trade secret agreement when departing employee absconded with confidential information.
- Advising a client in a large-scale reduction in force, including ensuring WARN Act and state mini-WARN compliance and appropriate settlement agreements and disclosures across multiple jurisdictions.
- Representing a large retail client in a New Hampshire Department of Labor wage and hour and employment practices audit.
